- **4.)** Board Minutes September 17, 2015 minutes were approved as written.
- 5.) Monthly Financial Reports- Cliff reviewed the P and L Budget vs. Actual, Statement of Cash Flows, and Balance Sheet. Current cash flow is low. Fund drive and Zombie Prom will improve this.
